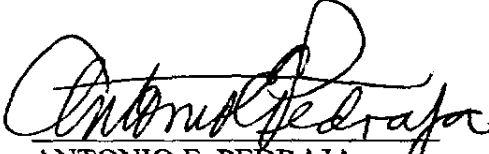
Article IX - Indemnification

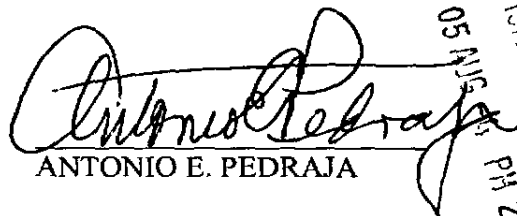
