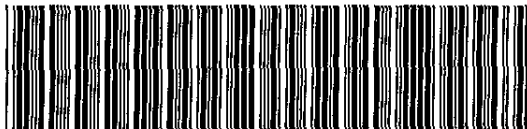

**ARTICLES OF INCORPORATION
OF
KCPATCH ENTERPRISES, INC.**

In compliance with the requirements of F.S. Chapter 607, the undersigned hereby act as incorporators in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation is: KCPATCH ENTERPRISES, INC., and the purpose for which the corporation is organized to conduct any and all lawful services in the State of Florida.

ARTICLE II

The street address of the principal office of the Corporation is: 422 Corvet Street, Fort Walton Beach, Florida 32547.

ARTICLE III
