**ARTICLES OF INCORPORATION**  
*of*  
***Hialeah Advanced Life Institute, Inc.***

THE UNDERSIGNED, has executed the following document as incorporator of above named corporation, a corporation organized under the laws of the State of Florida, and all rights duties and obligations of the undersigned as incorporator, and those of the corporation, are to be determined in accordance with the laws of the State of Florida.

**ARTICLE I.**

The name of this corporation shall be:

***Hialeah Advanced Life Institute, Inc.***

**ARTICLE II.**

This corporation shall commence existence upon the filing of these Articles of Incorporation by the Department of State, State of Florida, and shall have perpetual existence.

**ARTICLE III.**

The general nature of the business and objects and purposes proposed to be transacted and carried on by this corporation are to do any and all of the things therein mentioned, as fully and to the same extent as natural persons might do, viz:

- (1) Transact any and all lawful business.
- (2) Said corporation shall further have powers:
- (3) To have perpetual succession by its corporate name;
- (4) To sue and be sued, complain, and defend in its corporate name in all actions or proceedings;

(5) To have a corporate seal, which may be altered at pleasure, and to use the same by causing it, or a facsimile thereof, to be impressed, affixed, or in any other manner reproduced;

(6) To purchase, take, receive, lease, or otherwise acquire, own, hold, improve, use, and otherwise deal in and with real or personal property or any interest herein, wherever situated;

(7) To sell, convey, mortgage, pledge, create a security interest in, lease, exchange, transfer, and otherwise dispose of all or any part of its property and assets;

(8) To lend money to, and use its credit to assist, its officers and employees as provided by the laws of the State of Florida.

(9) To purchase, take, receive, subscribe for, or otherwise acquire, own, hold, vote, use, employ, sell, mortgage, lend, pledge, or otherwise dispose of, and otherwise use and deal in and with, shares or other interests in, or obligations of, other domestic or foreign corporations, limited liability companies, associations, partnerships, or individuals, or direct or indirect obligations of the United States or of any other governmental, state, territory, governments district, or municipality or of any instrumentality thereof;

(10) To make contracts and guarantees and incur liabilities, borrow money at such rates of interest as the corporation may determine, issue its notes, bonds, and other obligations, and secure any of its obligations by mortgage or pledge of all or any of its property, franchises, and income;

(11) To lend money for its corporate purposes, invest and reinvest its funds, and take and hold real and personal property as security of the payment of funds so loaned or invested;

- (12) To conduct its business, carry on its operations, and have offices and exercise the powers granted by this act within or without this state;
- (13) To elect or appoint officers and agents of the corporation and define their duties and fix their compensation;
- (14) To make and alter bylaws, not inconsistent with its articles of incorporation or with the laws of this state, for the administration;
- (15) To make donations for the public welfare or for charitable, scientific, or educational purposes;
- (16) To transact any lawful business which the board of directors shall find will be in aid of governmental policy;
- (17) To pay pensions and establish pension plans, profit sharing plans, stock bonus plans, stock option plans, and other incentive plans for any or all of its directors, officers, and employees and for any or all of the directors, officers, and employees of its subsidiaries;
- (18) To be a promoter, incorporator, partner, member, associate, or manager of any corporation, partnership, joint venture, trust, or other enterprise;
- (19) To have an exercise all powers necessary and convenient to effect its purposes;
- (20) To identify any person who by reason of the fact that he is or was a director, office, employee or agent of the corporation to the full extent as permitted by Florida Statute §607.014;

The aggregate number of shares which this corporation shall have authority to issue is the total sum **one hundred (100 ) shares**, having an individual per value of **one dollar (\$1.00) per share**.


