ARTICLES OF INCORPORATION

OF

FRED BECK, P.A.

I, the undersigned, being of full age and being duly a licensed real estate salesperson under the laws of the State of Florida, do hereby subscribe for the purposes of forming and organizing a professional service corporation under Chapter 621 of the Florida Statutes, and hereby adopt and declare the following Articles of Incorporation covering the existence and organization of this corporation:

ARTICLE I

The name of the corporation shall be Fred Beck, P.A.

ARTICLE II

This corporation is formed to engage in every phase and aspect of the practice of real estate sales under Chapter 475 of the Florida Statutes.

ARTICLE III
