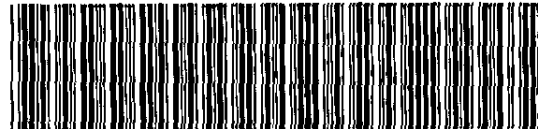

**ARTICLES OF INCORPORATION
OF *International Book Production*, INC.**

ARTICLE I – NAME

The name of this for-profit Corporation shall be *International Book Production*, Inc.

ARTICLE II – PRINCIPAL OFFICE
