**ARTICLES OF INCORPORATION
OF
Clean Wash Laundry & Drycleaning, Inc.**

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is Clean Wash Laundry & Drycleaning, Inc.. The Corporation shall engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE II

The existence of the Corporation shall begin on August 4th, 2005.
