**ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME AND BUSINESS ADDRESS

The name of this Corporation is Quality Services & Products, Inc. Its principal office address and business mailing address is 2525 Ponce De Leon Boulevard, Suite 400, Coral Gables, Florida 33134, Attention: Robert B. Macaulay.

ARTICLE II - DURATION

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

The purpose of this Corporation is to engage in any activities or business permitted under the Laws of the United States and Florida.

ARTICLE IV - CAPITAL STOCK

The maximum number of shares which this Corporation is authorized to have outstanding at any time is 10,000 shares of common stock, having a par value of \$.01 per share.




