

ARTICLES OF INCORPORATION OF CARL A. BUCK, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation is CARL A. BUCK, INC.

ARTICLE II - NATURE OF BUSINESS

The general character, purpose, and nature of business to be transacted by this corporation is to solicit, sell and provide insurance coverage, as well as any other activity or business legally permissible under the applicable laws of the State of Florida or the United States of America.
