The undersigned, for the purpose of forming a professional service corporation under Florida Law, and who is a natural person competent to contract, does hereby adopt the following Articles of Incorporation:

**ARTICLE 1**

The name of this Corporation shall be.  
TOGETHER LANDSCAPE ARCHITECT, INC.

**ARTICLE 2**

This Corporation shall have perpetual existence.

**ARTICLE 3**

This Corporation is organized for the purpose of rendering the specific professional service as a real estate broker.


**ARTICLE 4**

The aggregate number of shares which the Corporation is authorized to issue is one thousand shares (1,000) shares, of common stock, with a par value of ONE (\$1.00) DOLLAR per share.

**ARTICLE 5**

The number of Directors constituting the initial Board of Directors of the Corporation is ONE (1). The number of directors may be either increased or decreased from time to time in accordance with the By-laws of the Corporation. B. Notwithstanding the amending process contained in Paragraph A above, amendments may be made upon written approval by all of the Stockholders.
