ARTICLE I

NAME OF CORPORATION

The name of this Corporation shall be:

ARTICLE II

FRINCIPAL OFFICE AND MAILING ADDRESS

AUTHORIZED SHARES

In the event of any liquidation, dissolution or winding-up of the Corporation, whether voluntary or involuntary, the holders of Common Stock are entitled to share ratably in the net assets, if any, remaining after payment in full of all debts and liabilities of the Corporation and after the holders of any outstanding class or series of capital stock making senior to Common Stock shall have been paid in full the amounts to which such holders shall be entitled, or an
