PLAN OF MERGER

The undersigned entities, desiring to merge one into the other, hereby adopt this Plan of Merger, pursuant to Florida statute 607.1101, 607.1103, 607.1105, and other applicable Florida statutes, and state as follows:

- 1. SUNPAK USA, INC., a Florida corporation, Document Number P05000071901, filed with the Secretary of State of the state of Florida on May 16, 2005, is merging into SUNPAK CARIBE, INC., a Florida corporation, Document Number P05000110944, which was filed with the Secretary of State of the state of Florida on August 10, 2005. SUNPAK CARIBE, INC. shall be the surviving corporation.
- 2. Upon the effective date of the Merger, SUNPAK USA, INC. shall cease to exist and the surviving corporation shall be SUNPAK CARIBE, INC.
