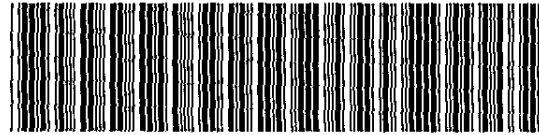

The undersigned hereby organizes and subscribes to these Articles of Incorporation under the laws of Florida.

I.

The name of the corporation shall be:

II.

The specific purpose for which the corporation is organized is to engage in any and all activities a real estate licensee is authorized to perform by Part I of Chapter 475, Florida Statutes, and shall include the transaction of any or all lawful business for which corporations may be incorporated under Chapter 621, Florida Statutes. 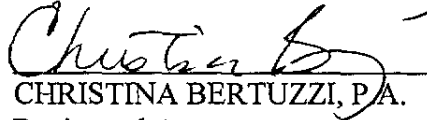
