#### ARTICLES OF INCORPORATION

OF

#### NAPA DIRECT, INC.

The undersigned, for the purpose of forming a Corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

#### ARTICLE L - CORPORATE NAME

The name of the Corporation is NAPA DIRECT, INC.

#### ARTICLE IL - CORPORATE DURATION

The duration of the Corporation is perpetual, and the Corporate existence is to commence upon the execution hereof.
