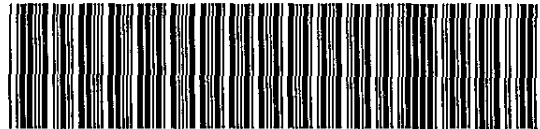

### **NATURE OF THE BUSINESS**




