Pursuant to the provisions of Section 607.1005 of the Florida Business Corporation Act, the undersigned, on behalf of Venturian Group Inc., a Florida corporation incorporated on August 11, 2005, and having Florida File Number P05000112079, hereby adopts the following Amended and Restated Articles of Incorporation:

ARTICLE I, NAME
