S. AUG. IN. S. AUG. IN. S. C. AUG. I The undersigned subscriber to these Articles of Incorporation is a Natural Person competent to contract and hereby form a Corporation for profit under Chapter 607 of the Florida Statutes.

ARTICLE I - NAME

ARTICLE XII REGISTERED OWNERS


