The undersigned, for the purpose of forming a corporation for profit under the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

**ARTICLE I**

**Name, Location and  
Mailing Address of Principal Office**

The name of the corporation is The Deane Agency, Inc. The principal office and mailing address of this corporation is 2184 Brighton Bay Trail West, Jacksonville, Florida 32246

**ARTICLE II**

**Purpose**

This corporation is organized for the purpose of transacting any and all business permitted under the laws of the United States or the State of Florida.

**Capital Stock**
