ARTICLES OF INCORPORATION OF

SKL International, Inc.

The undersigned, in order to form a cosporation for the purpose hereinafter stated, under and pursuant to the General Corporation Act of the State of Florida, do hereby certify as follows:

ARTICLE I

NAME

The name of this corporation is: SKL International, Inc.

ARTICLE II PURPOSE

The general nature of the business to be transacted by this corporation shall be:

- P) To buy, sell, and deal in, with or without guarantee of payment thereof, bonds and mortgages and other like accurities and other kinds of property, whether real or personal, nor prohibited or specifically excepted by law, and to do and prosecute any facts or things incidents to or proper in connection with the carrying on of the business of the corporation.
