## ARTICLES OF INCORPORATION OF MIAMI GARDEN GROUP, CORP.



The undersigned incorporator to these Articles of Incorporation, a natural person, competent to contract, hereby forms a Corporation under the laws of the State of Florida.

#### ARTICLE I.

#### NAME

The name of the Corporation shall be MIAMI GARDEN GROUP, CORP.

## ARTICLE II. PRINCIPAL OFFICE

#### **ARTICLE VIII.**

#### **INSPECTION OF BOOKS AND RECORDS**
