**ARTICLES OF INCORPORATION**

The undersigned, acting as incorporator of A QUALITY SEPTIC SERVICE, INC., under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

**ARTICLE I. NAME**

The name of the corporation is:

**ARTICLE II. ADDRESS**

**ARTICLE III. COMMENCEMENT OF EXISTENCE**

The existence of the corporation will commence at 12:01 a.m. on the date of filing of these Articles of Incorporation.

**ARTICLE IV. PURPOSE**

The corporation is organized to engage in any activity or business permitted under the laws of the United States and Florida.

**ARTICLE V. AUTHORIZED SHARES**

The maximum number of shares that the corporation is authorized to have outstanding at any time is 10,000 shares of common stock having a par value of \$0.01 per share.

#### ARTICLE VI. INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the corporation is 604 Highway 17/92 North, Haines City, Florida 33844 and the name of the corporation's initial registered agent at that address is JANE ANN MOBLEY.

#### ARTICLE VII. INITIAL BOARD OF DIRECTORS


