ARTICLES OF INCORPORATION
OF
TALLAHASSEE, FLORIDA

ARTICLE I - NAME

The name of this corporation is **Barrows Enterprises**, **Inc.** located at, 1225 Montego Bay Dr. North, Merritt Island, Florida, 32953.

ARTICLE II - DURATION

This corporation shall have a perpetual existence commencing upon the filing of these Articles of Incorporation by the Department of State.

ARTICLE III - PURPOSE

ARTICLE XIII - AMENDMENT

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendment hereto as provided by applicable law, and any right conferred upon the shareholders is subject to this reservation.

ARTICLE XIV - I.R.C. SECTION 1244 STOCK
