

ARTICLES OF INCORPORATION

ARTICLE I. NAME

NAME: The name of this corporation is PEGGY LEONARD CLEANING SERVICES, INC.

ARTICLE II. DURATION

This corporation shall have perpetual existence, commencing on the 10th day of August, 2005.

ARTICLE III. PURPOSE

This corporation is organized for the purpose of providing professional cleaning services for commercial, industrial or private purposes and for the general public. The corporation is authorized to transact any and all other lawful business in the State of Florida and the United States of America.

ARTICLE IV. CAPITAL STOCK

This corporation is authorized to issue 7,500 shares of (\$1.00) par value common stock.

ARTICLE V. PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.




