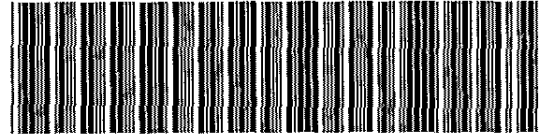

ARTICLES OF INCORPORATION  
OF  
FREEDOM REHABILITATION CENTER, INC.

The undersigned incorporator to these Articles of Incorporation, by these articles form a corporation for profit, pursuant to the laws of the State of Florida.

FIRST. The name of the corporation is FREEDOM REHABILITATION CENTER, INC.

SECOND. The period of duration of the corporation is perpetual.

THIRD. The purpose is to engage in any activity permitted under the laws of the United States and Florida.

FOURTH. The aggregate number of shares of Capital Stock which the Corporation has authority to issue is 5000, all of which shall be one class of common stock having a par value of \$ 1.00.

FIFTH. The address of its initial registered office is 7801 W. 36<sup>th</sup>. Ave. # 202, Hialeah, Fl 33018 and the name of the initial register agent at such address is RAUL ALMENDRO.


TENTH. The Corporation shall indemnify incorporator, officer and directors to the full extent permitted by law.
