Atwell, the undersigned, who is licensed as a sales associate under Chapter 475 of the Florida Statutes, do hereby make, subscribe, acknowledge and file with the Secretary of State of the State of Florida, these Articles of Incorporation for the purpose of forming a professional service corporation for profit in accordance with the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation shall be: DONALD P. ATWELL, P.A.

ARTICLE II - PURPOSE

The purpose for which this corporation is formed is to conduct business as a real estate sales associate licensed under Chapter 475 of the Florida Statutes and to do everything necessary, proper, or convenient for the accomplishment of such purpose and to do every other act incidental thereto which is not forbidden by the laws of the State of Florida or by the provisions of these Articles of Incorporation.
