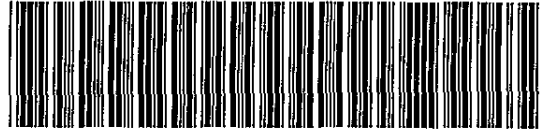



**ARTICLES OF INCORPORATION
OF

In compliance with the requirements of F. S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

**Article I
Name of Corporation**

The name of the corporation (the "Corporation") is **Nat's Home Maintenance, Inc..**

**Article II
Principal Office**

The principal place of business is 331 Kathleen Place, Ft. Walton Beach, Florida 32548. The mailing address of the Corporation is 331 Kathleen, Place, Ft. Walton Beach, Florida 32548.




