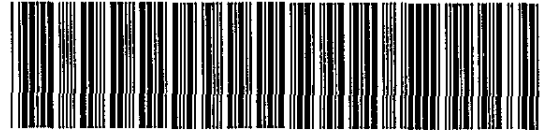

**ARTICLES OF INCORPORATION**

The undersigned incorporator, for the purpose of forming a corporation for profit pursuant to Chapter 621 of the Florida Statutes and laws of the State of Florida, hereby adopts the following Article of Incorporation.

**ARTICLE I**

**NAME**

The name of this corporation is DOLAGHAN LAW FIRM, P.A..

**ARTICLE II**

**PRINCIPAL OFFICE**


