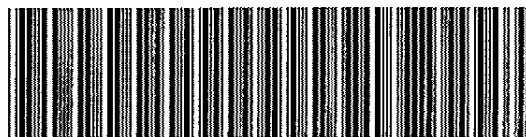

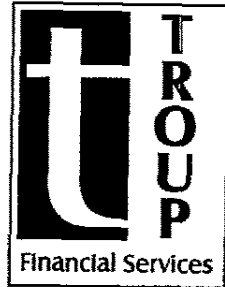

ARTICLE I
NAME

The name of this corporation is: **C B PAVERS & LANDSCAPE, INC.**

ARTICLE II
DURATION

This Corporation shall exist perpetually.

ARTICLE III
PURPOSE

This Corporation is organized for the purpose of operating as a Paver & Landscape Design & Maintenance Company, and to operate any lawful business.

ARTICLE IV
CAPITAL STOCK

POWERS

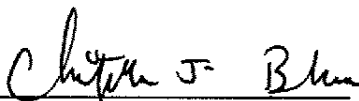
This Corporation shall have all of the Corporate powers enumerated by the Florida General Corporation Act, and as otherwise provided by law.

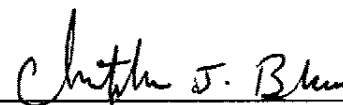
