ARTICLES OF INCORPORATION

OF

ERIC CARTER, M.D., P.A.

ARTICLE I

Name and Duration

The name of the Corporation is Eric Carter, M.D., P.A. The duration of the Corporation is perpetual. The effective date upon which this Corporation shall come into existence shall be the date these Articles are filed by the Secretary of State.

ARTICLE II

Principal Office

The address of the principal office of the Corporation is 12254 Lake Valley Drive, Clermont, Florida 34711.

ARTICLE III

Registered Office and Agent

The address of the registered office in the State of Florida is 1512 S. Orange Avenue, in the City of Orlando, County of Orange. The name of the registered agent at such address is Eric Carter, M.D.

ARTICLE IV

Corporate Purposes, Powers and Rights

- 1. The nature of the business to be conducted or promoted and the purposes of the Corporation are to engage in the practice of medicine specializing in emergency medical services and any lawful act or activity allowed in accordance with the Florida Statutes.
- 2. In furtherance of its corporate purposes, the Corporation shall have all of the general and specific powers and rights granted to and conferred on a corporation by the Florida Business Corporation Act and Chapter 621 of the Florida Statutes.

ARTICLE XI

Transfer of Shares

If, from time to time, a shareholders' agreement among all of the shareholders of the Corporation is in effect, then transfers of the Corporation's Common Stock made, not in accordance with such agreement, whether by operation of law or otherwise, are null and void <u>ab initio</u>.
