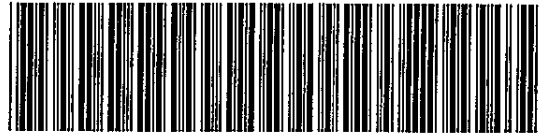

**ARTICLES OF INCORPORATION
OF

ARTICLE 1 – NAME

The name of the Corporation is NORTHSTAR METRO LAWN CARE, INC.
