CERTIFICATE OF INCORPORATION

The undersigned hereby associate us together for the purpose of becoming a corporation under the laws of State of Florida. Providing for the formation, rights privileges immunities and liabilities of incorporation for profit.

ARTICLE I

The name of the corporation should be:

ARTICLE II

The corporation will engage in any activity or business permitted under the laws of the

State of Florida and the United States of America.

ARTICLE III

The maximum number of shares which the corporation is authorized to issue and have outstanding at any one time is 100 shares of common stock, which shares shall be of non par value. All stock is to be issued as fully paid and exempt from assessment.

ARTICLE IV

The pledge, sale, transfer or other disposition of the capital stock may be governed and restricted by the by-laws or written agreement among the stockholders which shall be on file in the office of the corporation.

The amount of capital with which its corporation may begin doing business shall be not less than five hundred dollars (\$500.00).
