ARTICLE I-NAME

The name of the corporation shall be SPECIALTY LANDSCAPING, INC.

ARTICLE II-PRINCIPAL OFFICE

The principal office of this Corporation shall be located at 251 West 8th Street, Chuluota, Florida 32766.


