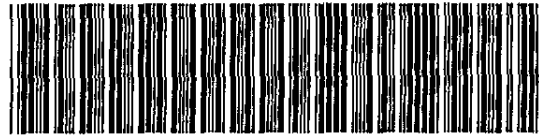

**ARTICLES OF INCORPORATION  
OF

I, the undersigned, acting as incorporator under the Florida Business Corporation Act, adopt the following Articles of Incorporation for such Corporation:

**Article 1**  
**NAME**

The name of the corporation is John Fain Enterprise, Inc.

*The use of the name John Fain, as used in these Articles of Incorporation, is in honor of the incorporator deceased great-grandfather, John Fain, Sir.*

**Article 2**  
**PRINCIPAL OFFICE**

The address of the corporation's initial registered office shall be: 1885 Mathis Road. St. Cloud, Florida 34771

**Article 3**  
**PURPOSE**

The purpose for which the corporation is organized is to engage in all aspects of promoting the union of the Fain Family. The corporation shall further have unlimited power to engage in and do any lawful act concerning any and all lawful business for which corporations may be organized under the Florida Business Corporation Act and any amendments thereto.

**Article 4**  
**SHARES**

{1} The corporation shall have authority to issue Ten Thousand (10,000) common shares. Each share represent 0.01 percent of the ownership of the corporation .

**Article 5**  
**DIRECTORS**

{1} The corporation shall have four members on the Board of Directors which shall be *approved* by the Registered Agent:

(a) President

(b) Vice-President

(c) Secretary

(d) Treasurer

(2) The powers of the Board of Directors shall be defined, limited and regulated by the registered agent.

(3) The corporation shall be managed by bylaws.

(a) The bylaws shall be adopted and amended from time to time by the Board of Directors.

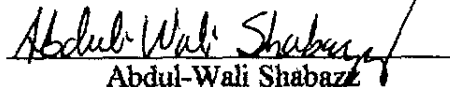
(b) The bylaws shall contain a provision to protect the Board of Directors from personal damage in civil action against the corporation.

(c) The bylaws shall contain a provision regulating the appointment and removal of Directors and the Registered Agent.

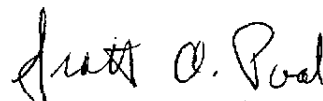
