**ARTICLES OF AMENDMENT
TO THE ARTICLES OF INCORPORATION
OF
MY SEARCH ENTERPRISES, INC.
a Florida corporation**

Pursuant to the Florida Business Corporation Act, Article I of the Articles of Incorporation of **My Search Enterprises, Inc.**, a Florida corporation, hereinafter referred to as the "Corporation", is amended to read as follows:
