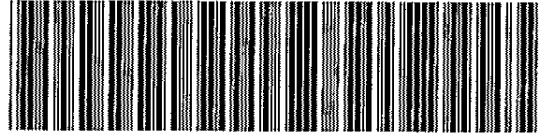

## **ARTICLES OF INCORPORATION**

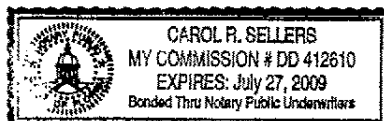
