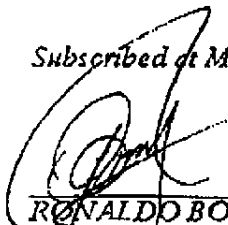
ARTICLE IX

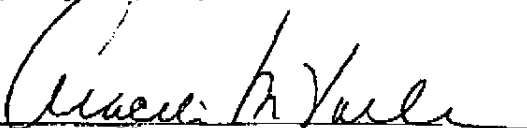

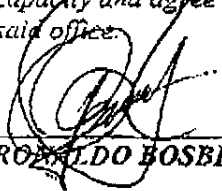
