# **ARTICLE I - NAME**

The name of this corporation is SIMPLY NECESSARY, INC.

#### **ARTICLE II - PURPOSE**

This corporation is organized for the purpose of engaging in the business of selling baby products, or any other lawful business and to do anything necessary, proper, advisable, or convenient, for the accomplishment of said purposes, and to do all and other things incidental to them, or connected with them, that are not forbidden by the Florida corporation laws or by other laws, or by these Articles of Incorporation, and to carry out said purpose in any state, territory, district, or possession of the United States or in any foreign country, to the extent that these purposes are not forbidden by the laws of that state, territory, district, or possession of the United States, or by the foreign country.

### ARTICLE III - CAPITAL STOCK
