# Articles Of Incorporation Of Affordable Service Center, Inc.

Article i Name

The name of the corporation is Affordable Service Center, Inc.

#### Article II Applicable Law

The Corporation is organized pursuant to the provisions of the Florida Business Corporation Act.

#### Article III Duration

The Corporation will commence its corporate existence as of the filing of these Articles of Incorporation and will have a perpetual duration.

#### Article IV Purpose

The Corporation is organized for the purpose of transacting any and all lawful business authorized and not prohibited by the Fiorida Business Corporation Act, as the same may be from time to time amended.

#### Article V Capital Stock

The Corporation will have authority, acting by its board of directors, to issue not more than ten thousand (10,000) shares of common stock having no par value.

#### Article VI Initial Registered Office And Agent And Principal Office Of The Corporation

The street and mailing address of the initial registered office of business and principal office of the Corporation is 114 W. Woodward Avenue, Eustis, Florida 32726 and the initial registered agent of the Corporation at that address is Clindy Johnson. The principal office address and the registered office address is the same.

## Article VII Preemptive Rights

No holders of any class or series of shares of the Corporation will be entitled as matter of right, to any preemptive right to subscribe for or purchase any shares of any class or series, whether now or hereafter authorized, any options or rights to purchase any shares, or any bonds, debentures or other securities of the Corporation, whether or not convertible into or carrying any option to purchase any such shares.

## Article VIII Indemnification of Corporate Officers, Directors, Employees and Agents

The Corporation will indemnify any officer or director, or any former officer or director, to the fullest extent permitted by the Florida Business Corporation Act.

The Corporation shall indemnify any person:

- A. Who was or is a party, or is threatened to be made a party, to any threatened, pending, or completed action, suit, or proceeding, whether civil, criminal, administrative, or investigative (other than an action by, or in the right of, the corporation) by reason of the fact that he is or was a director, officer, employee, or agent of the corporation or is or was serving at the request of the Corporation as a director, officer, employee, or agent of another corporation, partr ership, joint venture, trust, or other enterprise against such costs and expenses, and to the extent and in the manner provided under Florida Law.
- B. Who was or is a party, or is threatened to be made a party, to any threatened, pencing, or completed action or suit by or in the right of the corporation to produce a judgment in its favor by reason of the fact that he is or was a director, officer, employee, or agent of the Corporation or is or was serving at the request of the corporation as a director, officer, employee, or agent of another corporation, partnership, joint venture, trust or other enterprise against such costs and expenses, and to the extent and in the manner provided under Florida Law.

The extent, amount, and eligibility for the indemnification provided herein will be made by the Board of Directors. Said determinations will be made by a majority vote to a quorum consisting of directors who were not parties to such action, suit, or proceeding or by the shareholders by a majority vote of a quorum consisting of shareholders who were not parties to such action, suit, or proceeding.

The Corporation will have the power to make further indemnification as provided under Florida Law except to indemnify any person against gross negligence or willful misconduct.

The Corporation is further authorized to purchase and maintain insurance for indemnification of any person as provided herein and to the extent provided under Florida Law.
