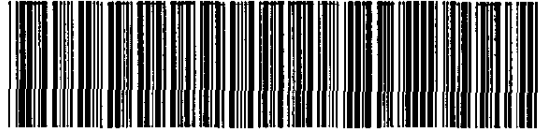

Article I
Identification


