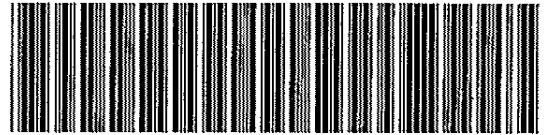



The undersigned subscriber to these Articles of Incorporation, a natural person, competent to contract, hereby sets forth his intention to form a corporation under the laws of the State of Florida.

**Article 1.    Name.**    The name of this corporation is **SPRING LAKE RANCH, INC.**

**Article 2.    General Purpose.**    This corporation is organized for the purpose of transacting any and all lawful business for which a corporation may be incorporated under the laws of the State of Florida.

**Article 3.    Capital Stock.**    This corporation is authorized to issue one thousand (1,000) shares of One Dollar (\$1.00) par value common stock.



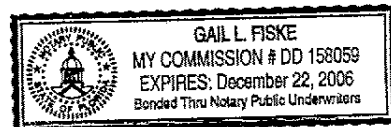
