



ARTICLES OF INCORPORATION  
OF  
FREY'S INTERIORS, INC.

The undersigned for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE ONE  
NAME

The name of the corporation is FREY'S INTERIORS, INC.

ARTICLE TWO  
DURATION

The term of existence of the corporation is perpetual.

ARTICLE THREE  
PURPOSE

The purpose for which the corporation is organized is to provide remodeling services and home repair services for profit.

The corporation may transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

ARTICLE FOUR  
CAPITAL STOCK

The aggregate number of shares which the corporation has authority to issue is one thousand (1,000), all of which shall be common shares with no par value.

REGISTERED OFFICE

ARTICLE EIGHT  
DIRECTORS

The board of directors shall consist of one member: Jeffrey G. Frey, 52 Windward Court, Port Orange, Florida 32127.

ARTICLE NINE  
INCORPORATORS

The name and address of the sole incorporator is: Jeffrey G. Frey, 52 Windward Court, Port Orange, Florida 32127.

ARTICLE TEN  
OFFICERS
