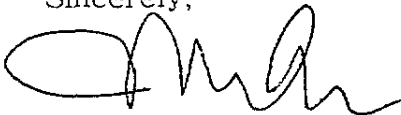

ARTICLES OF INCORPORATION  
OF  
LANGSTON BROTHERS POWER EQUIPMENT, INC

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is LANGSTON BROTHERS POWER EQUIPMENT, INC.

ARTICLE II

The existence of the corporation shall begin effective immediately.

ARTICLE III

The street address of the principal office of the Corporation is 809 SW 14TH STREET, CHIEFLAND, FL 32626.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is one hundred (100), all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders thereof shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

ARTICLE V

ARTICLE VI

The Corporation may be dissolved at any time (1) by unanimous written consent of the shareholders; or (2) on the affirmative vote of the holders of at least 60% of the outstanding shares of the corporation entitled to vote. On dissolution, the corporate property and assets shall, after payment of all debts of the corporation, be distributed to the shareholders pro rata, each shareholder to participate in the distribution in direct proportion to the number of shares held by the shareholder.

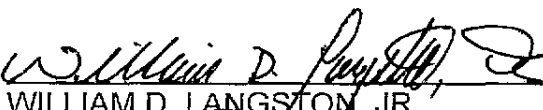

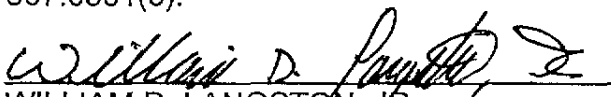
