Pursuant to Florida Statutes Chapter 607, including without limitation Sections 607.1003, 607.1004 and 607.1006, the undersigned corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation:

1. Article 5 of the Articles of Incorporation of Fana Medical Group, P.A., is hereby amended, changed and altered, in its entirety, to read as follows:
