ARTICLES OF INCORPORATION OF R & B AUTOMATION, INC.

ARTICLE I - NAME

The name of this corporation is R & B AUTOMATION, INC. The principal place of business of this corporation shall be 13901 NW 105th Lane, Lake Butler, Florida, 32054.
