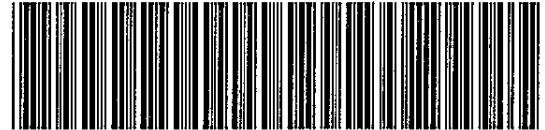

ARTICLES OF INCORPORATION

ARTICLE I- NAME

This Corporation shall have the power to act as Trustee.


ARTICLE X – INDEMNIFICATION


