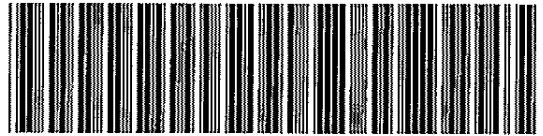

The undersigned, acting as Incorporator of KINGSBRIDGE CROSSING LIMITED, INC., a Florida corporation (the "Corporation") under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation:

ARTICLE I

NAME

The name of the Corporation is Kingsbridge Crossing Limited, Inc., and the street address of the initial principal office of the Corporation is 10563 Stonebridge Boulevard, Boca Raton, Florida 33498.

ARTICLE II

PURPOSE

The Corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under the laws of the State of Florida.

ARTICLE III

CAPITAL STOCK

The Corporation is authorized to issue 100,000 shares of \$0.01 par value Common Stock.


