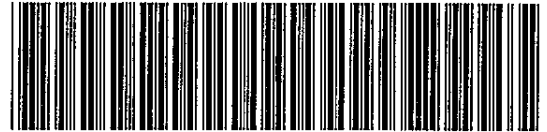

**ARTICLES OF INCORPORATION OF

FIRST: The name of this corporation is **PALACE PIZZA OF AUBURNDALE, INC.**

SECOND: The general nature of the business to be transacted by this corporation, together with and in addition to those powers conferred by the laws of Florida and the United States of American and the principles of common law upon corporations organized under and by virtue of the laws of Florida and the United States of American and the principles of common law upon corporations organized under and by virtue of the laws of Florida is the following, viz:

To engage in preparing and selling food and food products. To purchase and resell merchandise, to take, own, hold, deal in, mortgage or otherwise give lien against, and to lease, exchange, transfer or in any manner whatever, to dispose of real property within or without the State of Florida, wherever situated; To purchase or otherwise acquire in any lawful manner and to hold, own, mortgage, pledge or otherwise to give liens against, lease, sell, assign, transfer, or in any manner dispose of, deal in and trade with and invest in goods, wares and merchandise and property of any kind and class, both within the State of Florida and without said State .To do all and everything necessary and proper for the accomplishment of the objects enumerated in these Articles of Incorporation or any amendment hereof or necessary or incidental to the protection and benefit of the corporation, and to have and exercise all the powers conferred by the laws of the State of Florida upon corporations and, in general, to carry on any lawful business necessary or incidental to the attainment of the objects of the corporation, whether or not such business is similar in nature to the objects set forth in these Articles of Incorporation, and to perform any other act or thing which may tend to promote the interest of this Corporation and is not forbidden by the law to the same extent as natural persons might or could do, and the foregoing enumeration of specific powers, and is expressly provided that the foregoing enumeration of specific powers shall not be held to limit or restrict in any manner the powers of this Corporation.

THIRD: The maximum number of shares of stock that this Corporation is authorized to have outstanding at one time is ten thousand (10,000) shares of common stock having a par value of one dollar (\$ 1.00) per share.

FOURTH: the amount of capital with which this Corporation will begin business is five hundred and no/100 dollars (\$ 100.00).

FIFTH: This corporation is to exist perpetually.

SIXTH: The initial street address of the principal office of this corporation in the State of Florida is 114 South Kentucky Avenue, Lakeland, FL 33801.

SEVENTH: This Corporation shall have 1 Directors initially. The number of Directors may be increased from time to time by By-Laws adopted by the Stockholders, but shall never be less than one (1).

EIGHT: The name and street address of the members of the first Board of Directors, Incorporators and Subscribers to these Articles of Incorporation are:


