of

The undersigned, acting as Incorporator of Worldwide Quality Fishmounts, Inc., a Florida corporation (the "Corporation") under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation:

**ARTICLE I  
NAME**

**ARTICLE II


