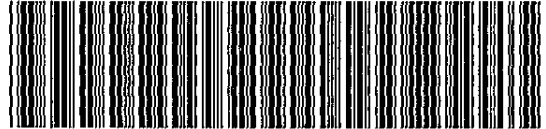

ARTICLES OF INCORPORATION

OF

J.R. DECKING, INC.

ARTICLE I - NAME

The name of this corporation is J.R. DECKING, INC.

ARTICLE II - DURATION

This corporation shall exist perpetually.


