

ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is Cosmopolitan Marketing Group, Inc.

ARTICLE II - PRINCIPAL OFFICE 3574 Ivanhoe Avenue Boynton Beach, Florida 33436

ARTICLE III - PURPOSE
