

ARTICLES OF INCORPORATION
OF
120 CORP

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of this corporation shall be 120 CORP

ARTICLE II - PURPOSE

The purpose of this corporation shall be to conduct any lawful business




